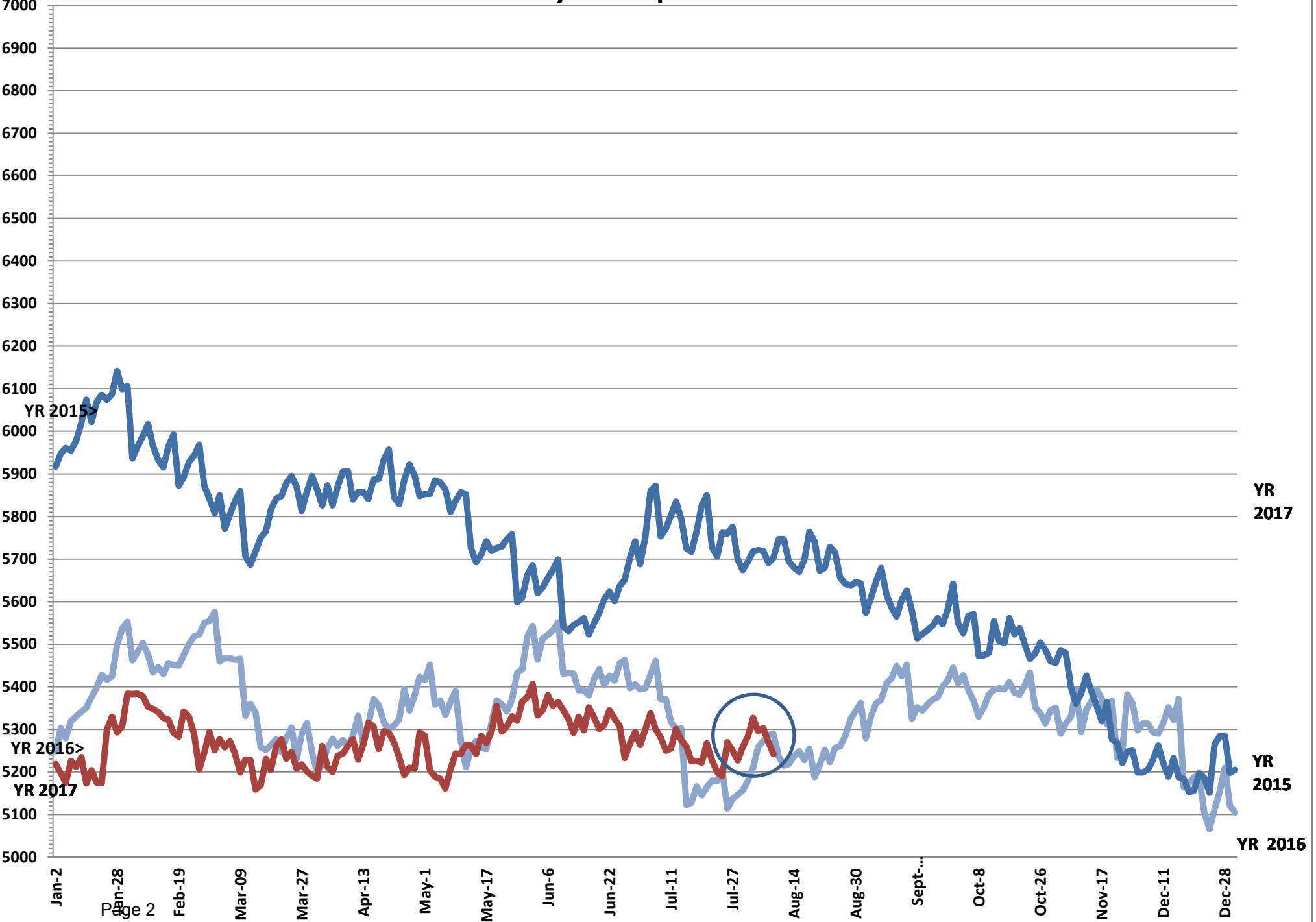

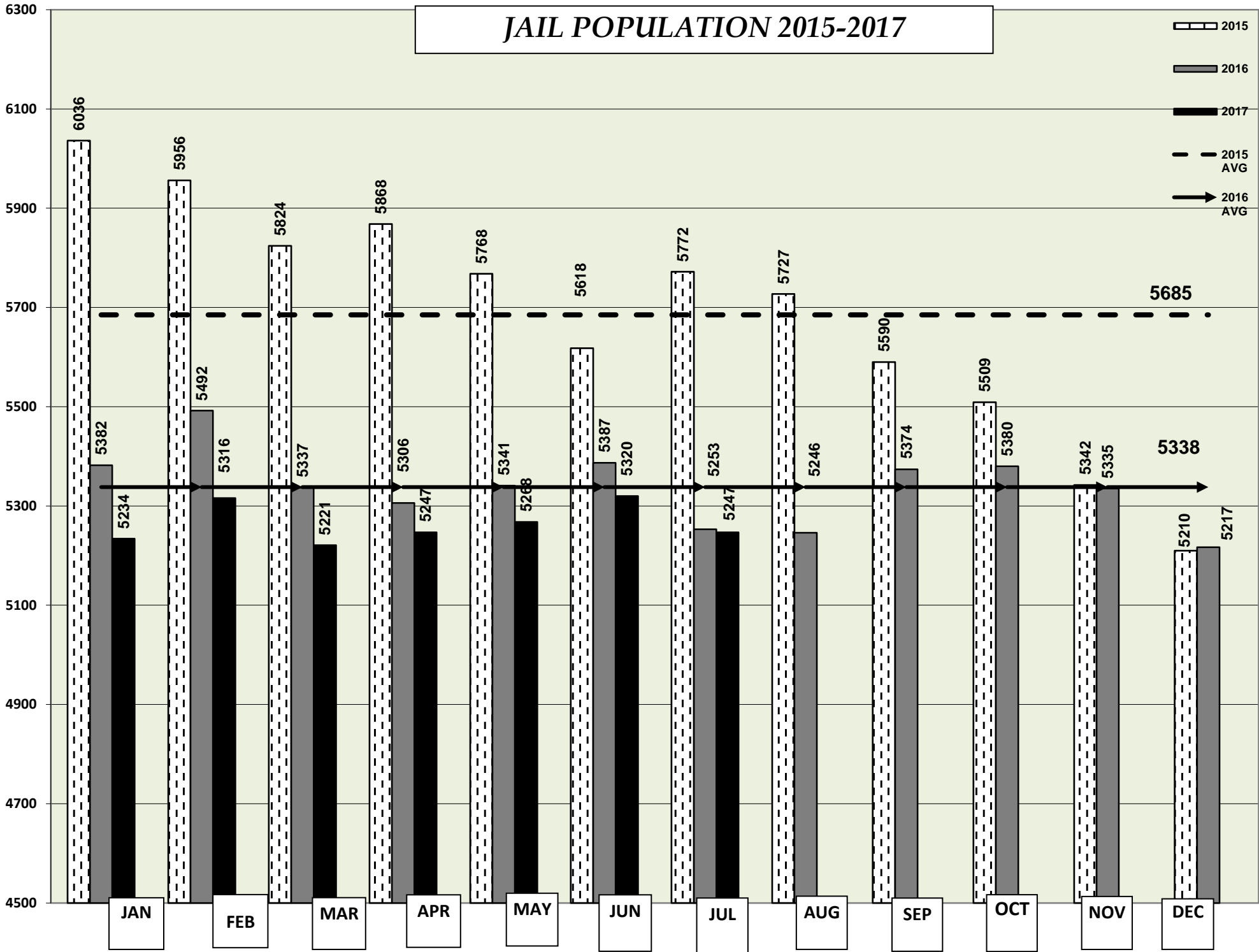

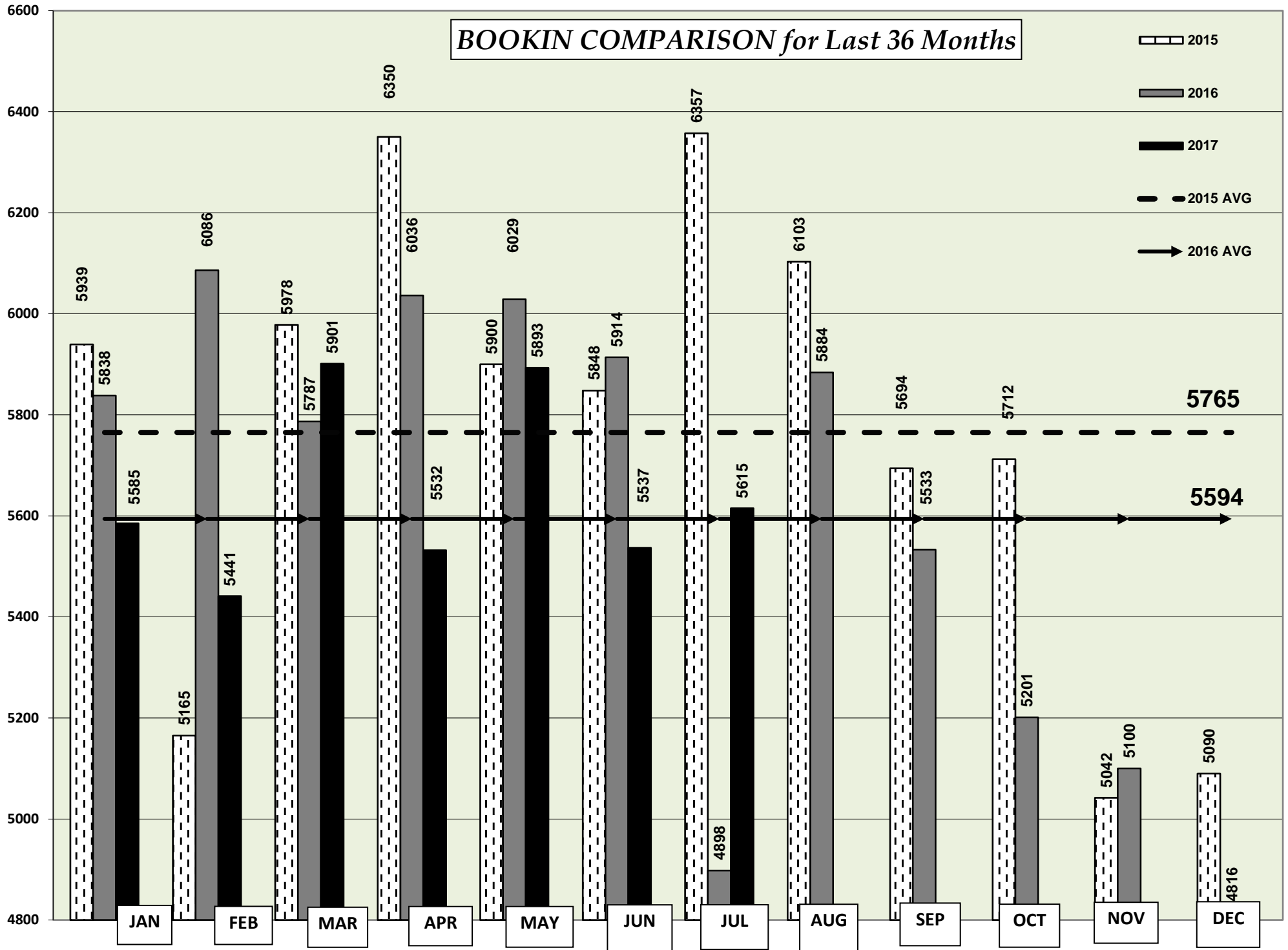

JAIL POPULATION 2015-2017

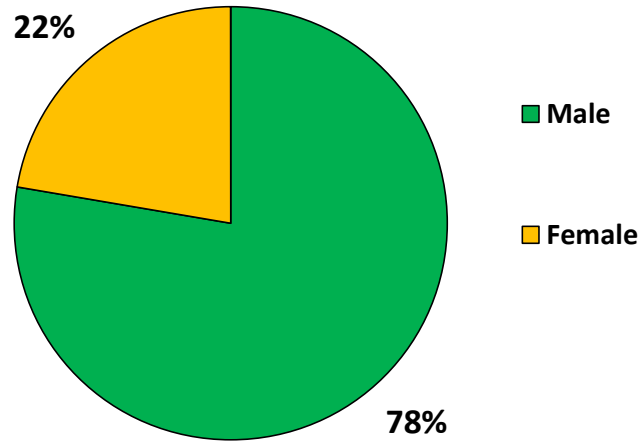


BOOKIN COMPARISON for Last 36 Months

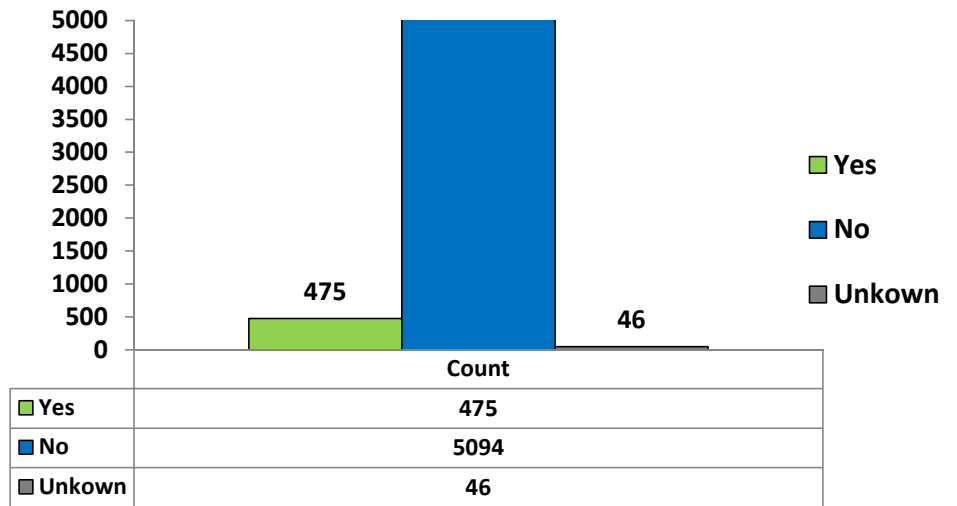


JULY 2017 BOOK-INS SNAPSHOT

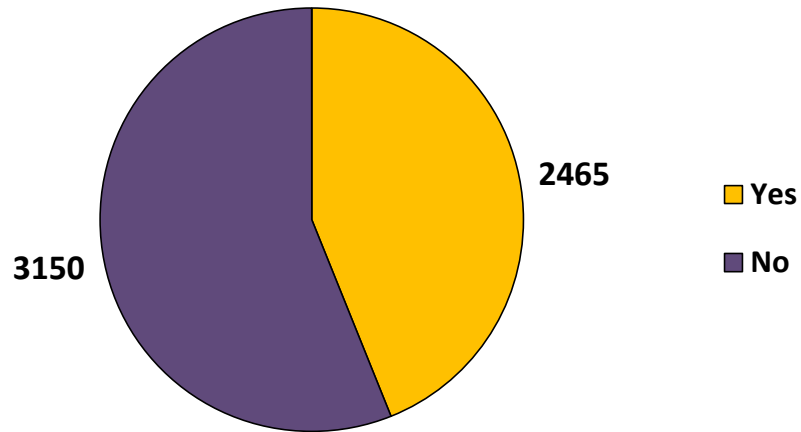
JULY 2017 BookIn Gender

JULY 2017 BookIn MH Flagged

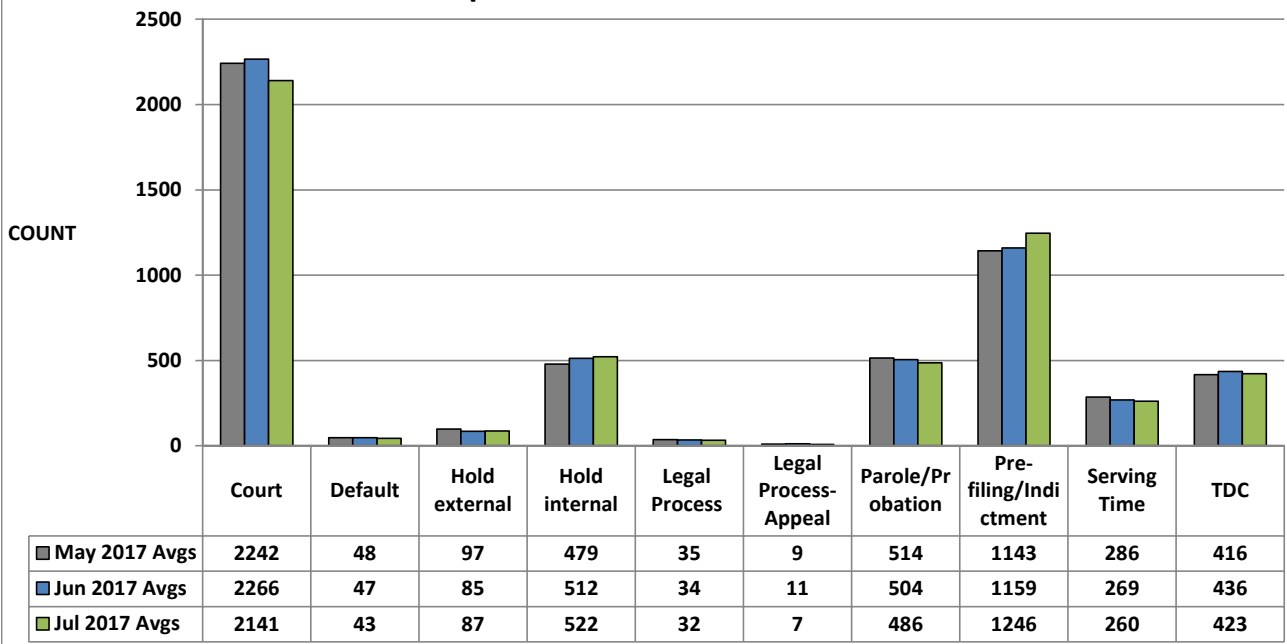

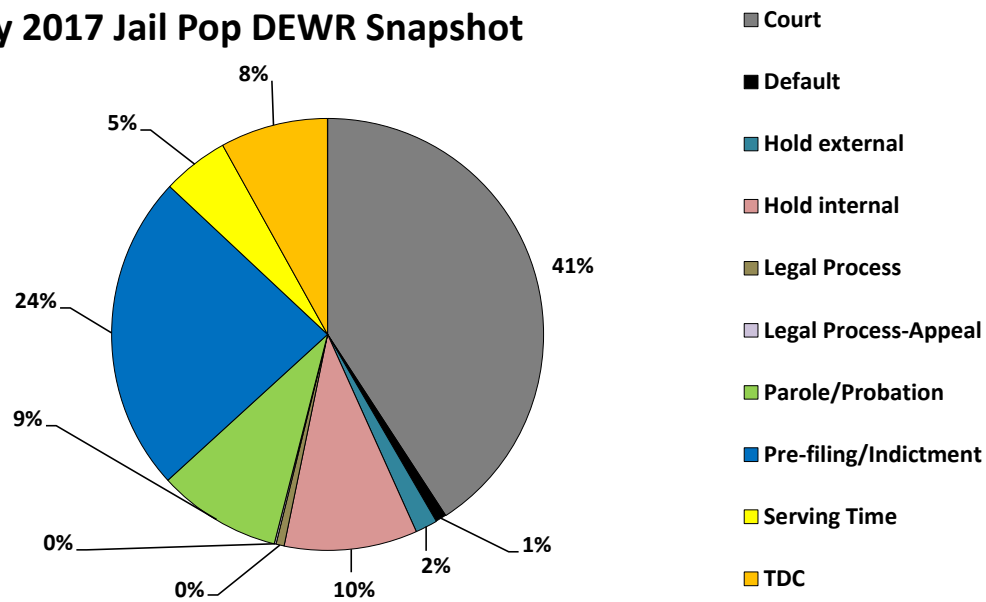

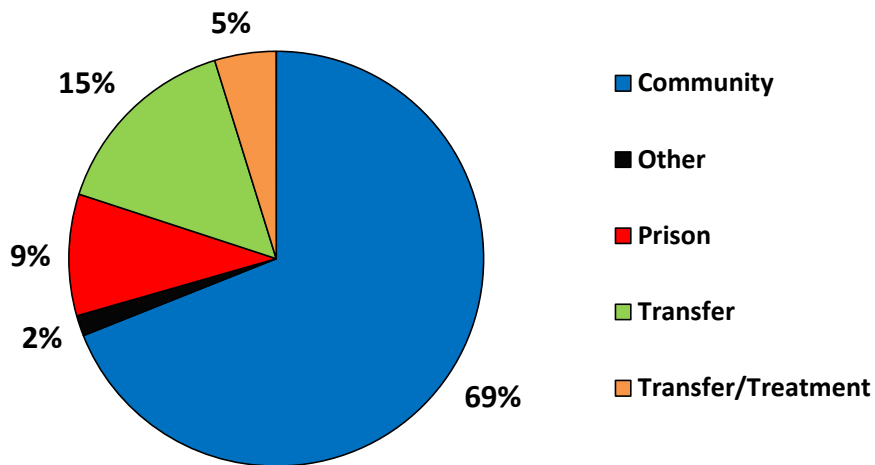

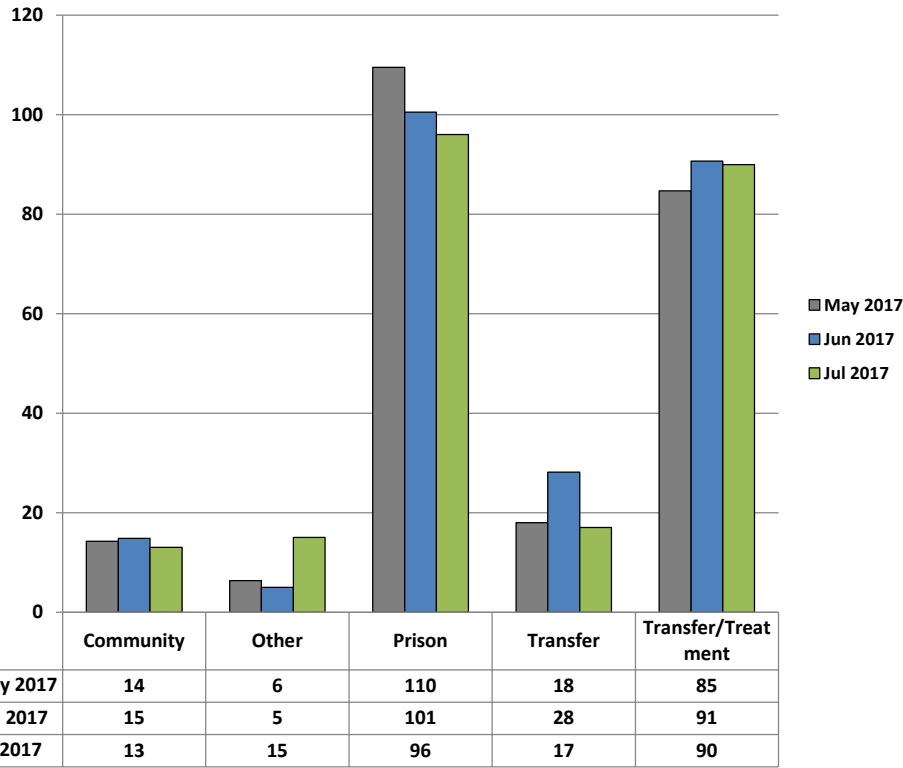
