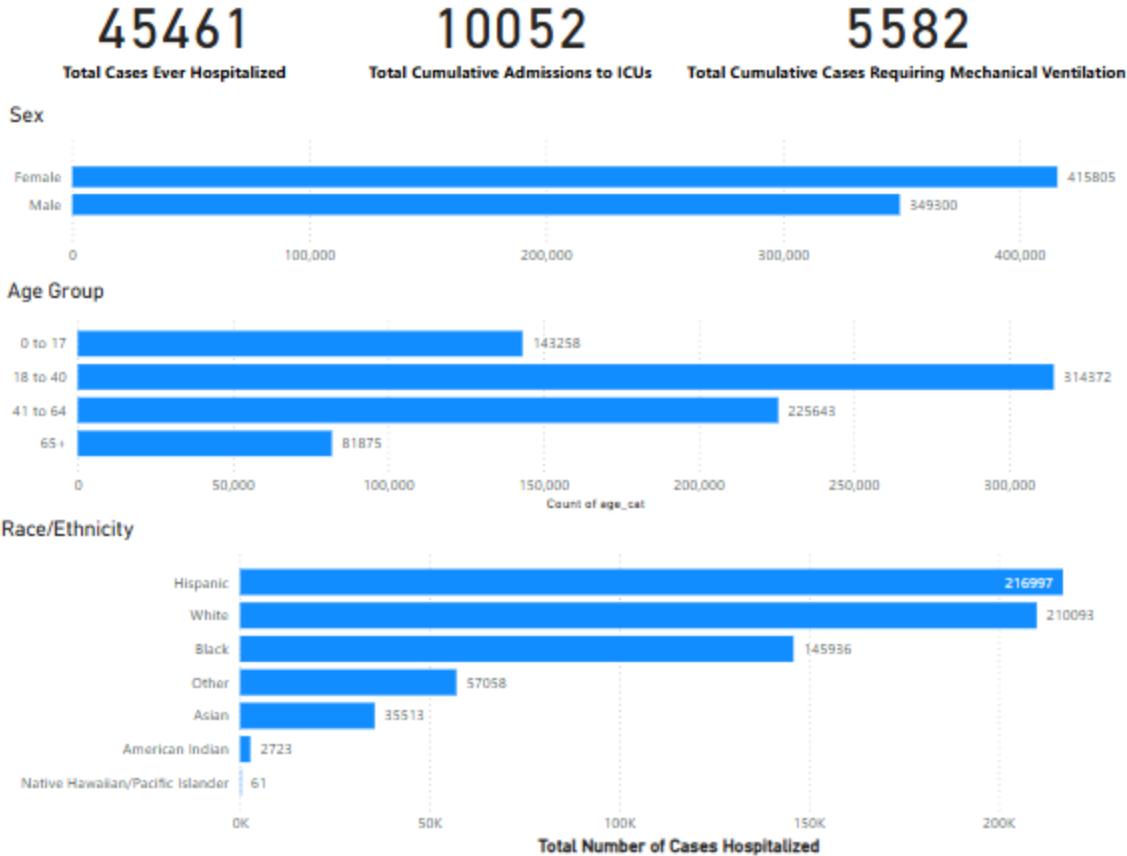

Total as of December 27, 2024



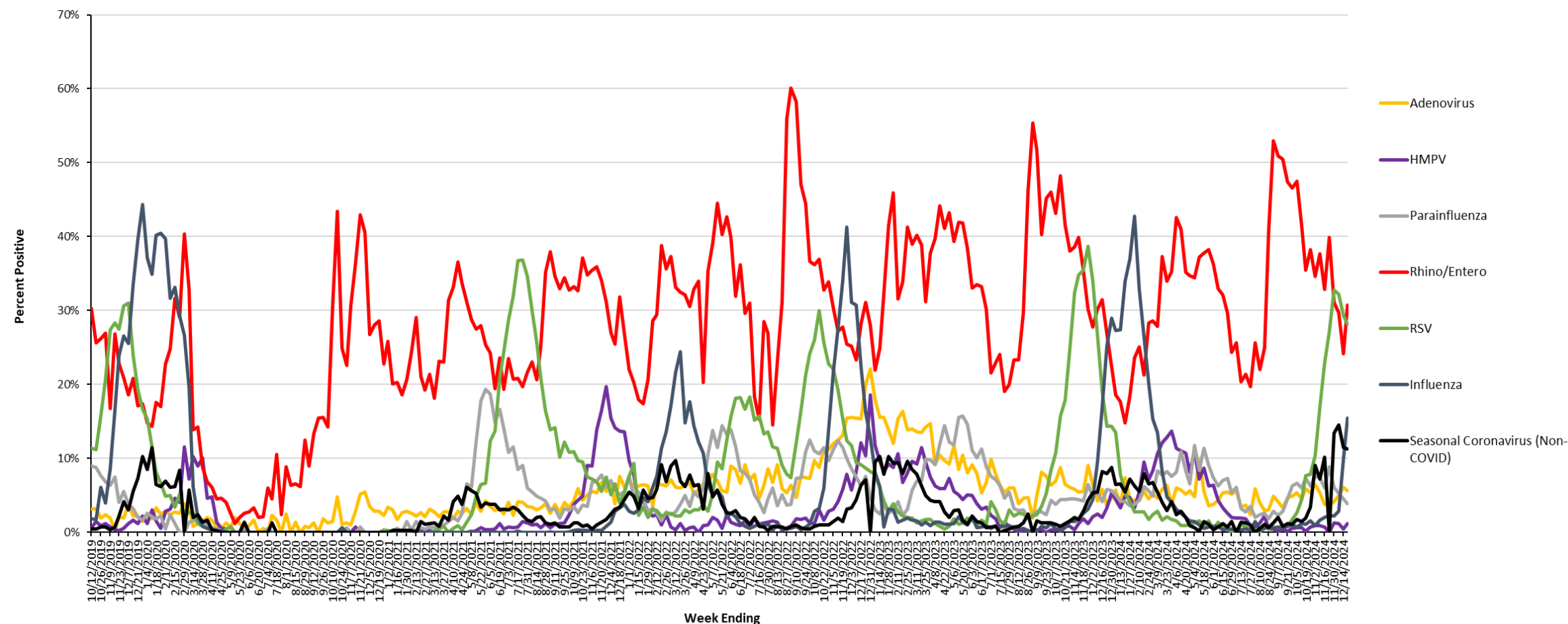

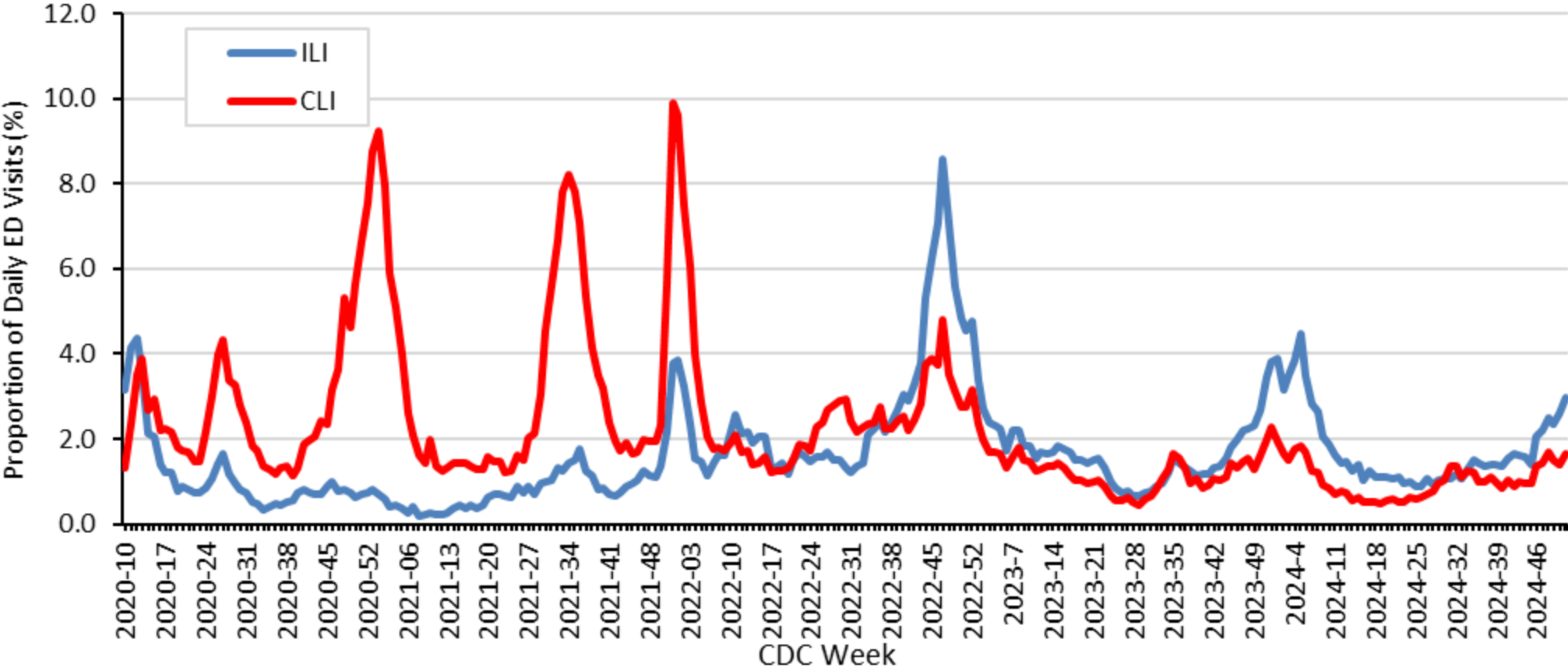
