Dallas County Health and Human Services Arbovirus Surveillance Report



Week 28 ending July 15, 2017

- In week 27, 18 mosquito traps tested positive for WNV. In week 28 to date, 35 mosquito traps have tested positive for WNV in zip codes: 75006, 75007, 75010, 75019, 75038, 75039, 75042, 75044, 75062, 75104, 75115, 75137, 75141, 75150, 75154, 75159, 75211, 75225, 75229, 75230, 75234, 75243, 75248, 75254.
- One human WNV case has been reported to date for 2017.
- In 2017, one travel-associated confirmed human Zika case has been identified in Dallas County. An additional 13 pregnant women with laboratory criteria for possible Zika infection have been reported to CDC for inclusion in the US Zika Pregnancy Registry.
- Aedes albopictus and Aedes aegypti are currently circulating in the area.




Figure 3: WNV Positive Mosquito Traps Collected During 2017: Weeks 27 and 28* (N=53)





Figure 4: Trap Counts of Female Cx. quinquefasciatus






Figure 6: WNV Vector Index by Week: 2012 - 2017 Seasons

Figure 7: Average Numbers of Female Cx. quinquefasciatus per Trap-night by Week: 2012 - 2017 Seasons









Figure 9: BG-Sentinel Trap Counts of Female Aedes aegypti and Aedes albopictus During 2017: Weeks 13 through 28


Figure 10: Average Numbers of *Aedes aegypti* per Trap-night: 2016 and 2017 Seasons^{*,†}
