Dallas County Health and Human Services 2016–2017 Influenza Surveillance Report

Week 16 ending April 22, 2017

Epidemiologic Summary

- Influenza activity decreased in Dallas County with 5.0% of tests returning positive during week 16. Nationally, 12.6% of specimens reported to CDC were positive for influenza.
- Daily numbers of emergency department visits for influenza-like illness in Dallas County were at baseline levels and 10 influenza-associated hospitalizations were reported during week 16.
- No influenza-associated deaths were reported in week 16. One influenza-associated pediatric death has been reported during the 2016-2017 season in Dallas County.
- RSV activity decreased with 3.0% of tests from area surveillance sites testing positive.







Figure 3. Hospitalized Influenza Patients by Week of Admission, Dallas County: 2015-2017 Seasons





Figure 5. Percentage of Student Absences by Week, Dallas County: 2015-2016 and 2016-2017
