

# Week 5 ending February 03, 2018

# **Epidemiologic Summary**

- Influenza activity remains high in Dallas County with 24.3% of tests returning positive during week 5. Nationally, 26.3% of specimens reported to CDC were positive for influenza.
- During week 5, in Dallas County the most frequently identified influenza virus type is now influenza B (54%). All influenza B strains tested locally have been the Yamagata strain.
- Daily numbers of emergency department visits for influenza-like illness in Dallas County remains high and 214 influenza-associated hospitalizations were reported during week 5.
- Two influenza-associated deaths of an adult were reported in week 5, and one was reported in week 6. One influenza-associated pediatric death has been reported during the 2017-2018 season in Dallas County.
- RSV activity continues to circulate.





# Figure 3. Influenza Hospitalizations by Week of Admission, Dallas County: 2013-2018 Seasons






Figure 4. Intensive Care Unit Hospitalizations for influenza by Week of Admission, Dallas County: 2013-2018 Seasons











