

Week 51 ending December 25, 2021

## **Epidemiologic Summary**

- Influenza activity remains low in Dallas County with 3.1% of tests returning positive during week 51.
- Twelve Influenza-associated hospitalizations were reported during week 51.
- One influenza-associated death of an adult was reported in week 44. No influenza-associated pediatric deaths have been reported during the 2021-2022 season in Dallas County.
- RSV continues to circulate locally, although activity has declined.





Figure 1. Influenza Positive Tests Reported to DCHHS by Hospital Laboratories: 2021-2022 Season







