

Week 48 ending December 2, 2023

Epidemiologic Summary

- 4.6% of Influenza tests returned positive during week 48 within Dallas County.
- Twenty-seven Influenza-associated hospitalizations were reported during week 48 within Dallas County.
- Zero influenza-associated pediatric deaths have been reported during the 2023-2024 season in Dallas County.
- The overall school absenteeism rate was 5.6% of which 0.03% was attributed to influenza-like illness during week 48 of the schools reporting within Dallas County.
- 34.1% of RSV tests returned positive during week 48 in North Texas.




Figure 2. Influenza Positive Tests Reported to DCHHS by Hospital Laboratories: 2018-2019 and 2022-2024 Seasons








Figure 4. Percentage of Student Absences Due to ILI by Week, Dallas County: 2018–2019 and 2022-2024 Seasons


