## Dallas County Health and Human Services 2024–2025 Influenza Surveillance Report

Week 41 ending October 12, 2024

## **Epidemiologic Summary**

- 0.6% of Influenza tests returned positive during week 41.
- One Influenza-associated hospitalizations were reported during week 41.
- Zero influenza-associated pediatric deaths have been reported during the 2024-2025 season in Dallas County.
- The overall school absenteeism rate was 4.3% of which 0.04% was attributed to influenza-like illness during week 41 of the schools reporting within Dallas County.
- 4.4% of RSV tests returned positive during week 41.

Figure 1. Influenza Positive Tests Reported to DCHHS by Hospital Laboratories: 2024—2025 Season





Figure 2. Influenza Positive Tests Reported to DCHHS by Hospital Laboratories: 2022-2025 Seasons




Figure 4. Percentage of Student Absences Due to ILI by Week, Dallas County: 2022-2025 Seasons


