

Week 04 ending January 25, 2020

Epidemiologic Summary

- Influenza activity remains high in Dallas County, with 28.5% of tests returning positive during week 4.
- Over the past week (Week 4), daily number of emergency department visits for chief complaints of influenzalike illness in Dallas County remains high. One-hundred and forty-eight (148) new influenza-associated hospitalizations were reported during week 4.
- RSV activity is decreasing with 7.3% of tests from the surveillance sites reported as positive.

Deaths occurring outside of influenza season require a positive PCR result in order to meet laboratory criteria. Positive RIDT will meet laboratory criteria after the start of flu season.

⁷ Possible influenza-associated deaths are defined as cases with laboratory-confirmed influenza, but pending final autopsy results for determination of primary cause of death



Figure 2. Influenza Positive Tests Reported to DCHHS by Hospital Laboratories: 2017-2020 Seasons



Figure 3. Influenza Hospitalizations by Week of Admission, Dallas County: 2014-2020 Seasons




Figure 4. Intensive Care Unit Hospitalizations for influenza by Week of Admission, Dallas County: 2014-2020 Seasons





Figure 5. Syndromic Surveillance of Emergency Department Visits for Influenza-like Illness (ILI), Dallas County: September 01, 2015 – January 24, 2020








Figure 7. Percentage of Student Absences by Week, Dallas County: 2018-2019 and 2019-2020

- **Deaths of persons with confirmed influenza** (any subtype). We are requesting all pediatric influenza-associated deaths to be reported *immediately* to facilitate specimen procurement and testing.
- Suspected influenza infections involving institutional outbreaks or a resident of any Long Term Care facility (please report *immediately*).
