Dallas County Health and Human Services 2019–2020 Influenza Surveillance Report

Week 40 ending October 5, 2019

Epidemiologic Summary

- Influenza activity remains low in Dallas County with 2.9% of tests returning positive during week 40.
- Daily number of emergency department visits for influenza-like illness in Dallas County remains low, and 3 Influenza-associated hospitalizations were reported during week 40.
- No influenza-associated deaths of an adult were reported in week 40. No influenza-associated pediatric deaths have been reported during the 2019-2020 season in Dallas County.
- RSV activity remains low with 12.4% of tests from area surveillance sites testing positive.

Figure 1. Influenza Positive Tests Reported to DCHHS by Hospital Laboratories: 2017—2020 Seasons





Figure 2. Syndromic Surveillance of Emergency Department Visits for Influenza-like Illness (ILI), Dallas County: September 1, 2015 – October 5, 2019




