



# Dallas County Health and Human Services 2021–2022 Influenza Surveillance Report

Week 47 ending November 27, 2021

## Epidemiologic Summary

- Influenza activity remains low in Dallas County with 1.1% of tests returning positive during week 47.
- Nineteen Influenza-associated hospitalizations were reported during week 47.
- One influenza-associated death of an adult was reported in week 44. No influenza-associated pediatric deaths have been reported during the 2021-2022 season in Dallas County.
- RSV continues to circulate locally, although activity has declined.

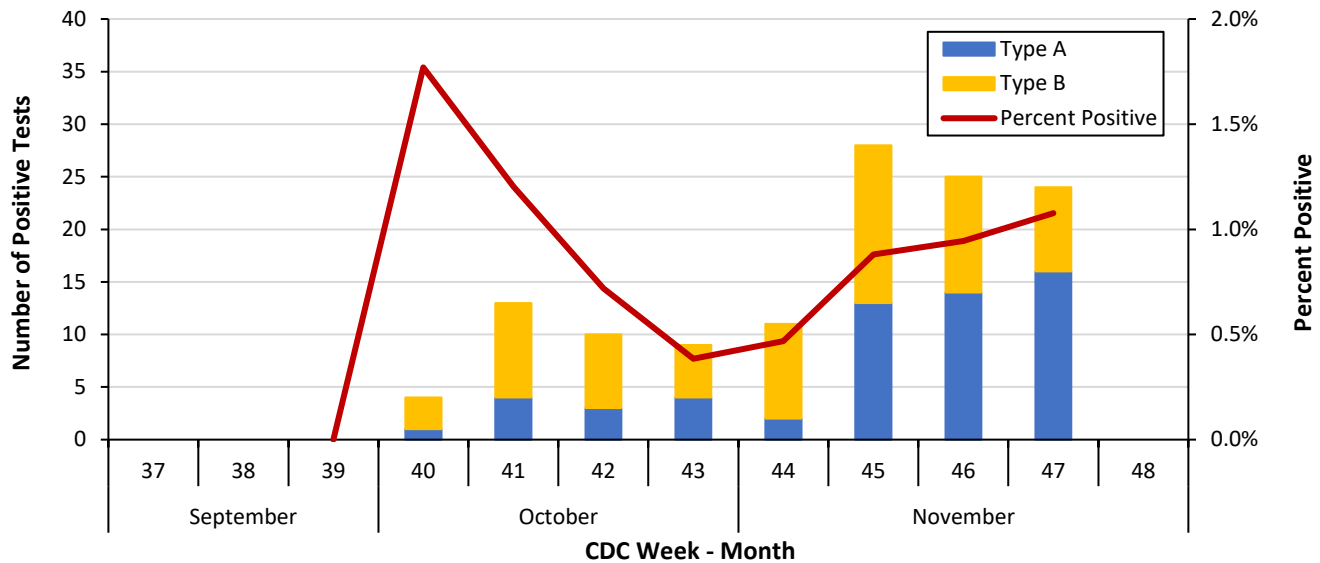

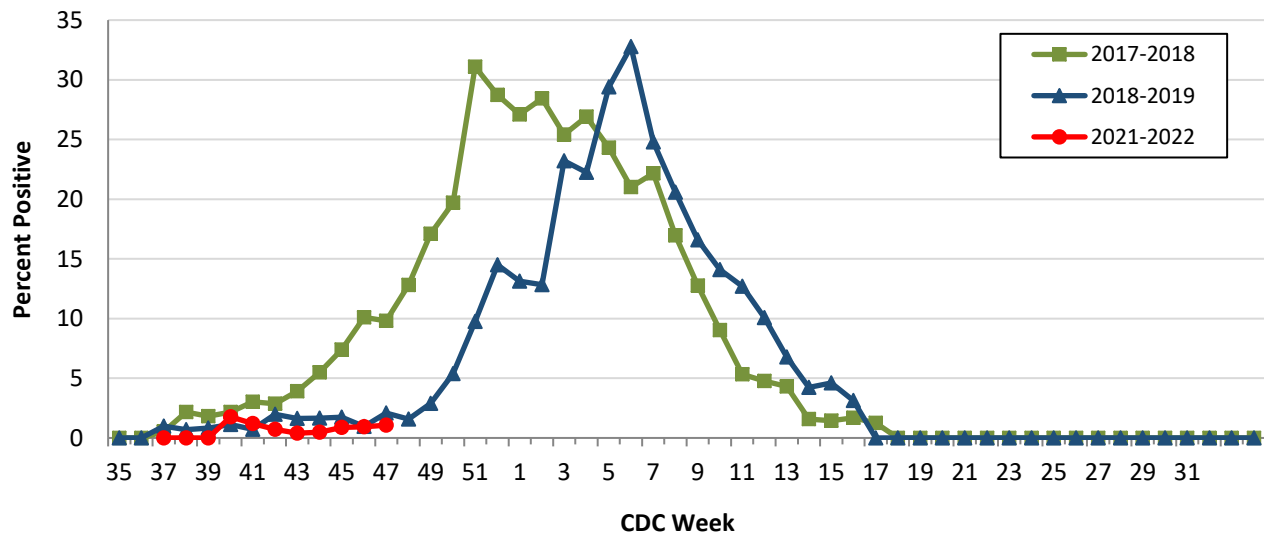

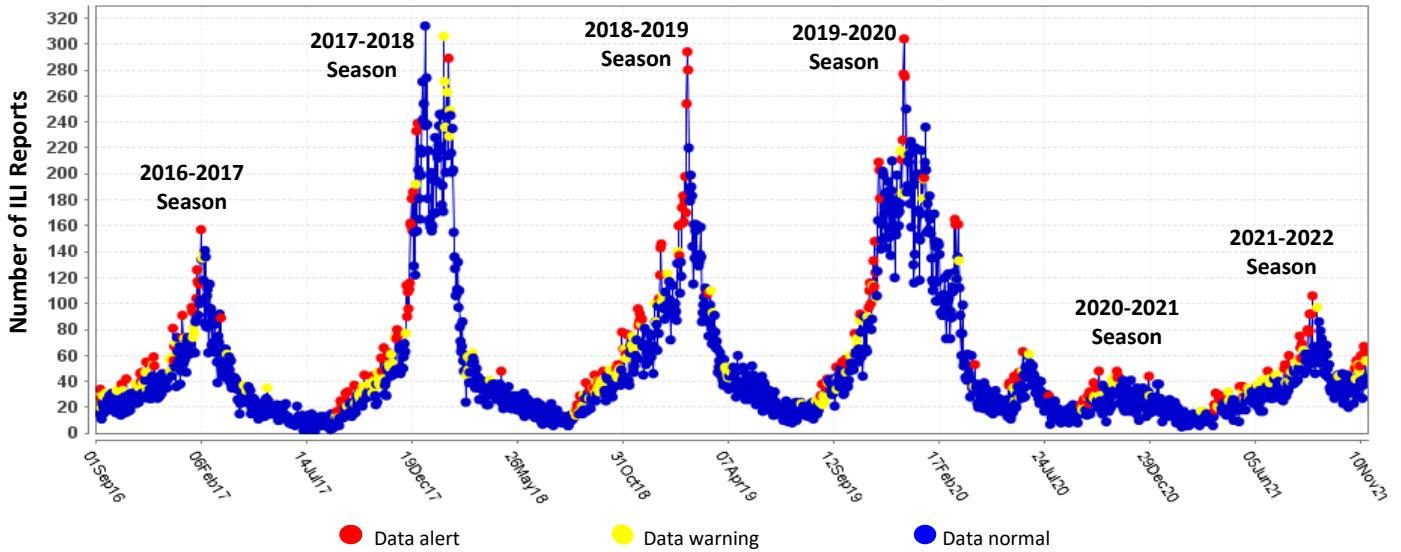

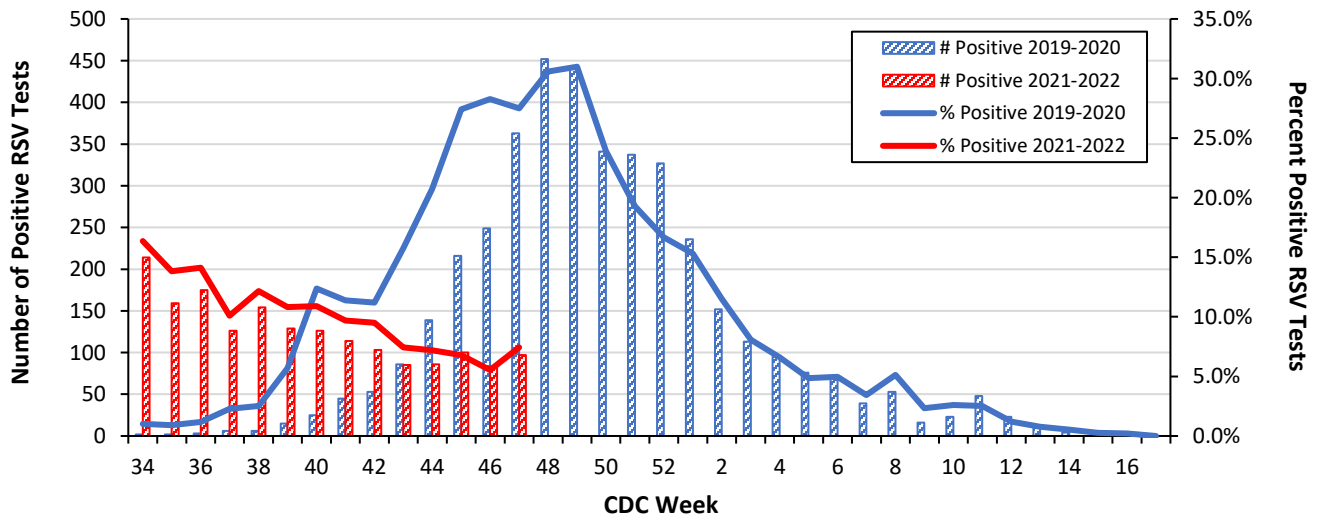
