

Week 48 ending December 01, 2018

Epidemiologic Summary

- Influenza activity remains low in Dallas County with 1.6% of tests returning positive during week 48.
- Daily numbers of emergency department visits for influenza-like illness in Dallas County were at baseline levels and seven influenza-associated hospitalizations were reported during week 48.
- No influenza-associated deaths were reported in week 48. No influenza-associated pediatric deaths have been reported during the 2018-2019 season in Dallas County.
- RSV activity remains high with 26.3% of tests from area surveillance sites testing positive.





Figure 1. Influenza Positive Tests Reported to DCHHS by Hospital Laboratories: 2016-2019 Seasons










Figure 4. Percentage of Student Absences by Week, Dallas County: 2017-2018 and 2018-2019
