Washington releases Public Health Preparedness and Emergency Response Planning Bill

Dallas County Health and Human Services (DCHHS) Director Zachary Thompson teamed up with public health experts across the nation to discuss the ongoing state of the Zika virus outbreak and how combatting Zika virus could be undermined as federal funding wanes. Thompson was joined by the Big Cities Health Coalition (BCHC), the National Association of County and City Health Officials (NACCHO) and the March of Dimes to host a webinar for media partners addressing the role of local health departments in fighting the disease with Public Health Emergency Preparedness funding.

Public Health Emergency funding aids local health departments to effectively respond to a range of public health threats, including infectious diseases, natural disasters, biological, chemical, nuclear, and radiological events.

The webinar took place after current administration proposed a 109 million dollar budget cut from the emergency preparedness fund, which directly impacts local health department's response in emergency situa-

"Any cuts to public health preparedness are unacceptable and we hope that this will be revisited by Congress," said Zachary Thompson, DCHHS director. "All public health is on a national level, however, you will see that the response is local. To have any cuts will have a dire impact on local health departments in terms of staffing and response."

Recently, July 12 the Federal Appropriations Committee in Washington released the Fiscal Year 2018 Labor, Health and Human Services and Education Funding Bill.

The bill introduces a different change through the CDC's Public Health Preparedness and Response budgeting. CDC related proposed changes include - \$198 million below the fiscal year 2017, however now includes an increase of \$45 million in Public Health Preparedness and Response programs.

Federal funding through the CDC directly impacts DCHHS Zika response. The majority of DCHHS emergency response staff is funded through public health preparedness. This includes the DCHHS Laboratory, Epidemiology (disease detectives), Environmental Health/ Vector Control and the overall local health department infrastructure.

DCHHS currently uses sustained funding for day to day tasks, however the emergency funding affects local preparation and response to disease outbreaks, including a potential locally transmitted case of Zika. In the state of an emergency, these funds are critical to protecting the health of citizens in Dallas County through disease prevention and intervention.

Zika Canvassing Exercise

Dallas County Health and Human Services (DCHHS) made local headlines after sending out a press release regarding the first boots on the ground Zika Canvassing exercise in Dallas County.

DCHHS and the City of Grand Prairie partnered with the Dallas County Medical Reserve Corps (MRC) to canvass Grand Prairie neighborhoods in preparation of responding to a locally acquired Zika case.

DCHHS staff, City of Grand Prairie and MRC volunteers placed boots on the ground, knocking on the doors of several Grand Prairie homes to assess DCHHS response planning procedures.

Together, nearly 50 staff members and volunteers walked door-to-door through Grand Prairie neighborhoods reaching

out to residents. Canvassing teams advised residents of the potential Zika threat; completed preliminary surveys and distributed informative Zika document packages to those who made contact with staff and volunteers.

DCHHS expects to handle public education and the clinical piece of the response in any scenario. Canvassing focuses on public health preparedness, laboratory and epidemiology capabilities.

In the event of locally acquired scenario, DCHHS will partner with the impacted municipalities on environmental health response, education, mosquito spraying and surveillance.

DCHHS is closely monitoring West Nile activity throughout the county. So far, West Nile is present in more than 46 zip codes county wide.

Recent data indicates that DCHHS is seeing a slight decrease in positive mosquito traps throughout municipalities. This year, recent laboratory results are showing 109 mosquito traps returning positive with West Nile.

The 2016 mosquito season shows the highest positive trap record in Dallas County. Data reports show that by July 1, 2016, DCHHS reported a total of 150 traps. Although positive traps are lower than predicted, DCHHS is familiar with sudden spikes in epidemiologic curves

July introduces the greatest risk of mosquito-borne disease transmission as temperatures continue to rise. DCHHS expects mosquito activity to heighten very quickly within the next month. Director Zachary Thompson participated in a press conference announcing the opening of Reliant "Beat the Heat" Centers in the City of Dallas at the West Dallas Multipurpose Center.

This is the second Dallas location following the Martin Luther King Jr Community Center.

Reliant Beat the Heat Center's are free and open to the entire community. The facilities feature airconditioned space, free bottled water, light snacks and entertainment for residents looking to cool off.

Residents should be mindful of the potential health risks that can result from an increase in temperatures.

To date, DCHHS is reporting more than 43 heat-related illnesses in Dallas County.

Heat-related illnesses can cause heat cramps, heat exhaustion, heat stroke and even death.

People 18 to 50 years old are most affected by heatrelated illnesses in Dallas County. During sweltering temperatures and potentially unsafe conditions, DCHHS would like to remind residents to practice heat safety and to remember heat-related illnesses are preventable.

Directors Award of Excellence. The award recognizes employees who have made significant contributions to the mission of the Department of Health and Human Services and the Office of the Regional Director.


