## **DEPUTY CONSTABLE I - EXAM REGISTRATION**(To be completed and submitted by applicant)

#### **Eligibility Requirements:**

- \* TCOLE (Texas Commission on Law Enforcement) certification as a Peace Officer and one of the following combinations: (1) thirty hours of college from an accredited college or university with a grade "C" or better in each class and one (1) year of law enforcement experience; OR (2) fifteen hours of college from an accredited college or university with a grade "C" or better in each class and two (2) years of law enforcement experience; OR (3) three years of law enforcement experience.
- \* Deputy Constable Recruit: A candidate may be considered for a Deputy Constable Recruit at a lower salary grade with a combination of TCOLE certification, education, and/or law enforcement work experience that equates to two years. (*These minimum qualifications are required prior to the candidate taking the written entry level law enforcement examination*). - \* I am at least twenty-one (21) years of age and possess a valid Texas Driver's License, with a good driving record.
- \* I am a citizen of the United States.
- \* I have not had a Peace Officer, jailer, or reserve license issued by the Texas Commission on Law Enforcement (or any other like issuing authority) revoked or suspended for any reason.
- \* I have not been convicted of an offense above the grade of a Class B misdemeanor or a Class B misdemeanor within the last ten years.
- \* I have never been convicted at any level of an offense involving family violence.
- \* I have not been prohibited by state or federal law from operating a motor vehicle.
- \* I have not been prohibited by state or federal law from possessing firearms or ammunition.
- \* I have one of the following: a high school diploma or a GED.
