- BE IT REMEMBERED, at a regular meeting of the Commissioners Court of Dallas County, Texas, held on 17th day of January 2012, on motion made by John Wiley Price, District #3, and seconded by Maurine Dickey, District #1, the following Order was adopted:
- WHEREAS, The Dallas County Commissioners Court was briefed on January 10, 2012, regarding a request from Human Resources/Civil Service Department for approval for Dallas County to enter into an Interlocal Agreement with the Dallas County Schools (DCS) to implement the 504 Workers' Compensation Program in Dallas County for a trial period of 24-months from date of implementation; and
- WHEREAS, Dallas County Schools (DCS) manages a Chapter 504 Workers' Compensation Program in accordance with Texas Labor Code § 504.053(b)(2), and Dallas County is authorized to enter into such an Agreement with DCS pursuant to the authority of the Texas Government Code, Chapter 791, the Interlocal Cooperation Act, and Chapter 2254, the Professional Services Procurement Act; and
- WHEREAS, DCS has operated its Program for over three years and currently has Interlocal Agreements with Dallas Independent School District (DISD), Dallas Area Rapid Transit (DART), and most recently, Tarrant County, with DISD and DART reporting savings and streamlined efficiencies, and with Dallas County anticipated savings of approximately \$125,000+ annually; and
- WHEREAS, The services to be performed by DCS is outlined in the Agreement, with the implementation of this program only impacting new claims *initially* and with the possibility of adding older claims later during the contract period, if feasible; and
- WHEREAS, Implementation of this 504 Workers' Compensation Program is anticipated to provide: a consistent application of Dallas County's Workers' Compensation policies and procedures, the achieving of medical management standards and best practices, potentially reduce costs, and is anticipated to have a positive impact on employees due to the streamlining of the process; and
- WHEREAS, Cost per claim is \$285 (one-time fee, life of claim) with this recommendation supporting Vision 1, Strategy 1.3: Dallas County provides sound, financially responsible, and accountable governance; and
- WHEREAS, The Civil Division of the District Attorney's Office has reviewed the attached Interlocal Agreement from DCS as well as the Purchasing Department.

IT IS THEREFORE ORDERED, ADJUDGED, AND DECREED that the Dallas County Commissioners Court hereby approve the Interlocal Agreement for the 504 Program between Dallas County and Dallas County Schools as outlined in the Interlocal Agreement and allow the County Judge to sign the Interlocal Agreement on behalf of the County.

- 3. I must go to my treating 504 workers' compensation doctor for all work related injuries. If I need a specialist, my treating doctor will refer me to someone in the 504 Dallas County network of physicians. If I require emergency care, I may go to any medical hospital.
- 4. I will be required to pay the bill if I get health care from someone other than a 504 Dallas County network doctor.
