PEACE BOND

A peace bond is a court order to keep the peace for a period of a year. When a Judge is informed upon oath that an offense is about to be committed against the person or property of the informant, or of another, or that any person has threatened to commit an offense, the Judge may issue a warrant or summons for the accused. Generally, a Peace Bond is not proper once a criminal offense has occurred.

Code of Criminal Procedure Article 7 governs Peace Bond.

The Judge has discretion on how the Judge's wishes to handle Peace Bond hearings. Following are the steps for this Court:

- **Step 1**-The affiant/complaining party will complete a Peace Bond Application.
- **Step 2** The Clerk will docket the case. There is no charge for the filing.
- **Step 3** The Clerk will set the case for an immediate ex parte hearing before the Judge. The Judge will hold a hearing to determine if a Peace Bond is the appropriate step. If appropriate, the Judge will set a second hearing for both parties to be present. The Clerk will mail notice to the defendant via regular mail.

In many cases it is inappropriate to file a peace bond and a protective order is more appropriate. The location and number for a protective order is as follows:
