

JUSTICE OF THE PEACE 4-1

STANDING ORDER ON APPEAL BONDS

On this day the Court issues the following order setting appeal bonds in justice court cases, forcible detainer cases, forcible entry and detainer cases, and administrative hearings.

IT IS THEREFORE ORDERED ADJUDGED AND DECREED that the bond for justice cases are set pursuant to Texas Rule of Civil Procedure (TRCP) 506.1. Unless otherwise noted on the judgment, the appeal bond is double the amount of judgment. This number is calculated by adding the amount of the judgment, attorney fees, pre-judgment and then multiplying that number by two. If no judgment is rendered against the appealing party or if the Plaintiff is appealing the appeal bond is set at \$500.00.

IT IS THEREFORE FURTHER ORDERED that the bond for forcible detainer and forcible entry and detainer cases are set pursuant to the TRCP 510.11. Unless otherwise noted on the judgment, the appeal bond is double the amount of judgment plus cost of court and one month's rent. This number is calculated by adding the rental judgment, attorney fees, filing fees and then multiplying that number by two. If no judgment is rendered against the appealing party or the Court fails to award a judgment for rent, attorney fees or cost of court the appeal bond is set at \$500.00. In the case of bank-owned properties and postforeclosure forcible detainers, the appeal bond is set for both parties at \$500.00.

IT IS THEREFORE FURTHER ORDERED that in an administrative hearing, unless otherwise set by statute, the appeal bond is determined by the Judge.

IT IS THEREFORE FURTHER ORDERED that the appealing party must pay county filing fees in the amount of \$______ made payable to John Warren, County Clerk of Dallas County by cashier's check or money order as well as the cost of a transcript made payable to the Justice of the Peace 4-1 in the amount of \$27.50 in the form of check, cash, money order or cashier's check.
