Judge Jenkins encourages individuals to sign up for health insurance

There are just 10 days before the February 15 deadline and the end of this year's Health Insurance Marketplace Open Enrollment. Consumers can still get enrollment information and assistance in the Dallas-Fort Worth area and within the next ten days, consumers can go in person to over 15 standing enrollment locations across the DFW metropolis.

Judge Jenkins said it's important to "sign up now to beat the last minute lines. There is nothing more important for you and your family than protecting your health."

Open Enrollment for the Health Insurance Marketplace for 2015 began Nov. 15, 2014, and runs through Feb. 15, 2015.
