Meeting:

- Chair opened the meeting and welcomed members and guests.
- The Secretary presented the minutes from the previous meeting held on March 2025.
 - A motion to approve the minutes was made by Tina Sanders and seconded by Luke Parton.
 - The minutes were approved as written by unanimous consent of the members present.

Presentations and Reports:

UNFI Facility Safety and Spill Preparedness

Presenter: Brian Chamberlin, UNFI

- Mr. Chamberlin delivered a comprehensive overview of UNFI's internal emergency preparedness framework, focused on hazardous materials management and spill response.
- Highlights included:
 - Implementation of a Continuity of Operations Plan (COOP) and Standard Operating Procedures (SOPs).
 - Regular training and spill response drills in partnership with the local fire department.
 - Deployment of spill containment systems and adequate PPE stockpiles.
 - o Internal and external communication protocols for emergency events.
 - Risk assessments performed to identify and mitigate vulnerabilities.
 - Support from Emergency Response Teams and LEPC partnerships.
 - o Commitment to post-incident audits and continuous improvement.
 - Environmental protection and public safety cited as core priorities.

Hazardous Rail Transport Overview

Presenter: Denisse Martinez

- Ms. Martinez presented findings from a Texas Commission on Environmental Quality (TCEQ)-funded rail transport study in partnership with Texas A&M.
- Key elements of the study:
 - Covered 233 miles of mainline and 165 miles of shortline/passenger rail across Dallas County.
 - o Assessed both loaded and residual cargo, including intermodal shipments.
 - Rail lines evaluated included:
 - Union Pacific (UP): Manolo, Ennis, and Dallas subdivisions
 - Kansas City Southern (KCS): White Branch and Dallas subdivisions
 - Short Line: Medill Subdivision
 - Top hazardous materials transported included:
 - Elevated Temperature Liquids, Diesel Fuel, Butane, Caustic Soda, Carbon Dioxide, Vinyl Acetate, Sulfuric Acid, Methanol, and various Class 9 environmental hazards.
- Hazard classes reviewed included: Explosives, gases, flammable liquids/solids, oxidizers, toxic inhalants, radioactive materials, corrosives, and other regulated materials.
- Cities were invited to request localized rail data. A highway hazardous materials study is currently pending approval.

Subcommittee Updates:

Training Subcommittee Report

- The newly formed Training Subcommittee provided an update on initiatives to enhance facility readiness and regulatory compliance.
- Key goals discussed included:
 - Supporting facility-level emergency exercises and Tier II reporting compliance.
 - Promoting stronger collaboration between Tier II facilities, LEPC stakeholders, and the State.
 - Developing tabletop exercise templates and providing centralized or on-site training.
 - o Encouraging active participation and idea-sharing among all LEPC members.

Officer Elections:

- Elections were held for officer positions following the completion of the previous two-year term.
 - Vice Chair Nominee: David Gifford
 - Noted for his dual experience in industry and local LEPC involvement.
 - Emphasized strengthening public-private collaboration and emergency preparedness.
 - Secretary Nominee: Tina Sanders
 - Background in damage prevention and regulatory compliance.
 - Advocated for increased engagement among LEPC participants.
 - Results:
 - David Gifford was elected Vice Chair.
 - Tina Sanders was elected Secretary.
