ADDENDUM #1

**RFP 2025-057-7082 INPATIENT SUBSTANCE ABUSE TREATMENT SERVICES FOR PREGNANT
WOMEN AND WOMEN WITH CHILDREN.**

Whereas,

The following language has been added to the RFP under “I. Introduction, Purpose and Intent” by way of this addendum: Dallas County is seeking proposals to establish a five-year service price agreement for the provision of substance use disorder inpatient treatment services specifically designed for pregnant women, women with children and/or adult women (hereafter referred to as “participants”).

The following language has been added to the RFP under “I. Introduction, Purpose and Intent” by way of this addendum: This agreement is designed for participants in the Dallas County Specialty Court Programs, Community Supervisions and Corrections Department, District Attorney’s Office, Public Defender’s Office, Judicial Courts, the 530 Sub-Committee, and defendants in the Dallas County criminal justice system. Referrals are based on funding availability from various funding sources.

The following language has been struck from the RFP, “I. Introduction, Purpose and Intent”: Participants shall not be required to submit any form of payment, including personal funds or third-party benefits, for services rendered under this agreement. Dallas County will fund the full cost of treatment for eligible individuals to ensure financial hardship does not serve as a barrier to care.

The following language has been added to the RFP under “I. Introduction, Purpose and Intent” by way of this addendum: Dallas County will fund services in accordance with the final cost fee schedule, as submitted and approved by the awarded vendor(s). Length of treatment will be determined by clinical needs and referring entities’ funding availability.

The following language has been added to the RFP under II. Specifications or Scope of Work by way of this addendum: Section “a”, Page 3. Residential Treatment for Women with Children (Women with children accompanying):

Provide residential treatment services to eligible women with children (ages 0–12), integrating child and family support components into the treatment plan. Services must promote family stabilization and support reintegration into the community, including but not limited to any state and federal school compulsory laws.

The following language has been added to the RFP under II. Specifications or Scope of Work by way of this addendum: Section “n”, Page 6.

Residential Treatment for Pregnant Women:

Provide residential treatment services to eligible pregnant women, providing access to all necessary prenatal, and potential postnatal and postpartum medical care. Services should include complimentary support services, such as case management and other recovery support. Vendor(s) should be prepared to accept any pregnant women referrals up to 30 weeks gestation.

The following language has been added to the RFP under II. Specifications or Scope of Work by way of this addendum: Section “o”, Page 6.

Residential Treatment for Adult Women:

Provide residential treatment services to eligible adult women (ages 18 and over). Services should include complimentary support services, such as case management and other recovery support.

The following language has been added to the RFP under II. Specifications or Scope of Work by way of this addendum: Section “p”, Page 6.

Detox Services:

Medically supervised services provided in a residential setting to safely manage acute physical withdrawal symptoms from alcohol or other drugs. These services should include 24-hour monitoring, medical interventions, and support to stabilize the individual physically to prepare them for entry into ongoing substance use disorder treatment.

Except as provided herein/above, all other specification requirements of the original solicitation referenced shall remain unchanged in full force and effect. This addendum should be signed and returned with your Solicitation package on or before 10/30/2025, @ 2:00 p.m. (CST).
