**Authorize 1) termination of a 12-month service price agreement, for Residential Services, for Dallas County Juvenile Department, for the period of March 4, 2024 through March 3, 2025, approved on March 5, 2024 by Court Order 2024-0212, with Athletes for Change - estimated amount \$150,000, Pegasus Schools, Inc. - estimated amount \$205,000, Center for Success and Independence - estimated amount \$28,000, Gulf Coast Trades Center - estimated amount \$120,000, and Shoreline, Inc. - estimated amount \$80,000 - Total estimated amount \$583,000 and 2) award a 15-month service price agreement, with two one-year renewal options, for Residential Services, for the Dallas County Juvenile Department, for the period of March 4, 2025 through June 19, 2026, with Pegasus Schools, Inc. - estimated amount \$625,000, Center for Success and Independence - estimated amount \$40,000, Gulf Coast Trades Center - estimated amount \$400,000, and Shoreline, Inc. - estimated amount \$275,000, the most advantageous proposers of five - Total estimated amount \$1,340,000**
