- I. Call to Order: RWPC Vice Chair, Ben Martinez called the meeting to order at 5:22PM (In order to meet quorum requirements the RWPC Vice Chair chaired the meeting)
- II. Certification of Quorum: Quorum was established and certified by RWPC Vice Chair Ben Martinez.

III. Introductions/Announcements:

- (a) Lionel Hillard announced that David Saenz will resign from the RWPC and as Vice Chair of the committee due to job relocation.
- **(b)** Melissa Grove announced that Legacy Counseling Center hosted it's Grace Project: HIV positive Women's Conference from May 17-19, 2013. There were over 180 women who attended.
- **IV. Approval of April 22, 2013 minutes:** *Lionel Hillard moved to accept the minutes with the modified changes. Patrick Brown seconded the motion. The motion passed unanimously.*
- V. 2012-2013 State Services Re-allocation: No Discussion.
- **VI. 2012-2013 Ryan White Part B Re-Allocation:** Crystal presented the committee with the FY 2012-2013 Re-Allocations Guide for the Dallas/Sherman Dennison HSDA Part B Allocation. The guide included budget and expenditures for FY 2013 (9/1/12-4/30/13), FY 2013 Service Category Priority Rankings, and Agency Requests for Categorical Funding Increase.
 - (a) (The committee took a ten minute recess to reviewed the information presented. The committee returned from recess at 5:30 p.m.)

The committee solicited comments from audience members. Some of the comments presented include:

- i. Steven Pace, AIDS Interfaith Network (AIN)- [transportation]AIN currently has a little over 200 people on a waiting list. The extra allocated funding should be enough to remove those individuals from the waiting list for one month.
- ii. Jennifer Hurn, Resource Center Dallas (RCD)- [food bank] RCD had expended the money given from the initial grant award in February 2013. In order to continue servicing clients, RCD began tapping into its own financial reserve. The re-allocated funds would cover the cost that the organization has had to provide in the absence of funding.

The committee recommended a 50/50 split of the remaining funds (\$13,296.04) to be distributed between the medical transportation and food bank service categories. (\$6,648.02 to each service category) The committee came to a consensus and will forward the suggested allocations to the Administrative Agency.
