- I. **Call to Order:** Pamela Green RN, Evaluation Committee Chair, called the meeting to order at 3:03 p.m.
- II. **Certification of Quorum:** Quorum was established by Pamela Green RN and certified by Claudy Jean-Pierre, RWPC Staff.
- III. **Approval of September 1, 2020 Minutes:** Helen E. Turner motioned to approve the minutes. Gary Benecke seconded the motion. The motion passed.
- IV. **Office of Support Report:** The Office of Support reported the following regarding the Evaluation Committee Membership Reflectiveness: Evaluation Committee (15 seats): 10 members (5 seats vacant). The 1<sup>st</sup> group impacted by HIV epidemic with the highest numbers is Black at 9,262 or 42% representation; the Evaluation Committee membership consists of 10 people of whom 3 are Black with representation of 30% reflectiveness. The 2<sup>nd</sup> group impacted by the HIV epidemic with the highest numbers are Whites at 6,530 or 30% representation; the Evaluation Committee membership consists of 10 people of whom 6 are White with representation at 60% reflectiveness. The 3<sup>rd</sup> group impacted by the HIV epidemic with the next highest numbers are Latin/Hispanic at 5,083 or 23% representation; the Evaluation Committee consists of 10 people of whom 1 is Latino/Hispanic with representation at 10% reflectiveness.

The office of support encouraged those who are interested in becoming a member of the committee to submit their RWPC membership application and a resume to the office of support.

**New Business:**

1. Pamela Green, RN announced that Del Wilson's seat as Vice-Chair will become vacant in the upcoming year (2021). Pamela encouraged council members to consider applying for the position.
2. Del Wilson confirmed that his seat, as Vice-Chair, will come to an end in 2021-2022. Del discussed the committee's application and leadership appointment processes then he expressed the importance of having a Vice-Chair in training who could be groomed to replace the chairs when the time comes.

3. Pamela Green, RN discussed the challenges associated with getting action items for the committee. Pamela mentioned that she, Del, Claudy, Justin and Oscar participated in a telephone call where they discussed action items. Pamela turned the meeting over to Claudy who revealed the Evaluation Committee's intentions to partner with the CQM. The committee brainstormed over other action items. Pamela announced that she will work on ideas independently (e.g. transgender specific items, MSM issues, and Latino X issues) and she encouraged committee members to do so as well.

4. Helen E. Turner reported that the Texas HIV Syndicate will work to get individuals, organizations, Ryan White, and non-Ryan White subcommittees all to collaborate. Helen announced that they completed their first webinar entitled the DYK (Did You Know) Series.

5. Pamela Green, RN announced that the committee will meet in December then asked Claudy to work with Justin or Oscar to gather documents that the CQM is requesting. Pamela confirmed that the two representative for the Evaluation Committee to the CQM are Del Wilson and Helen Turner.

V. **Adjournment:** Helen E. Turner motioned to adjourn. Del Wilson seconded the motion. The motion passed unanimously.

The meeting was adjourned at 3:39 p.m.
