- I. **Call to Order:** John Dornheim, RWPC Chair opened the meeting at 9:05 a.m. and established quorum at 9:12 am.
- II. **Certification of Quorum:** Quorum was established by John Dornheim, RWPC Chair and certified by Glenda Blackmon-Johnson, Ryan White Planning Council Manager.
- III. **Introductions/Announcements:**
 - a. Yolanda Jones announced that AIDS Service of Dallas seeks to hire for two part time positions: medical adherence peer. The Peers will assist with access to medical appointments in order to assist individual achieve medical compliance. Check the following website: <https://www.aidsdallas.org/> for additional information regarding the job posting.
 - b. Yolanda Jones announced that emergency financial assistance COVID-19 relief funds for the provision of financial assistance for rent, mortgage and utilities for the population impacted by COVID. Individual must be able to prove their COVID impact. An announcement flyer with the details and contact information will be forwarded to the office of support for distribution. Individuals may contact Yolanda directly at 214.941.0523 ext. 5111 or contact the main office.
- IV. **Approval of the November 11, 2020 Minutes:** Robert Lynn *motioned to accept the minutes as written. Pam Green seconded the motion. Four abstained. The motion passed.*
- V. **Administrative Agency Report** Sonya Hughes announced:
 1. That Tanya Jones, our long term administrative receptionist, passed away on November 30, 2020. Tanya's served with Dallas County for approximately 16 years; and, she was a few months away from retirement.
 2. The administrative agency is currently working to close out its corrective action plan with the Department of State Health Services. Updated policies are due for submission before the close of the month.

3. The first round of fund Re-allocations was approved in commissioner's court; reallocation recipients should receive doc-u-sign forms this week. The second round of reallocations from 11/30/2020 and the Carryover briefing will be on the next commissioner's court.
4. The year-to-date expenditures for Part A reflect 36% expended; and the year-to-date expenditures for Part B reflect 16% expended; State Services is a small percentage as well. Expense submissions from the larger entities are expected as well.

VI. Committee Reports:

- A. **Executive Committee:** John Dornheim, RWPC Chair, reported the committee met on December 2, 2020 and established quorum. The committee discussed the reallocation recommendations and sought to pass them forward to the RWPC. The committee voted and approved the forward of the Allocation committee's FY 2020 Part A/B Dallas/Sherman HSDAs/State Services Re-allocation Recommendations to the RWPC for the final approval. And, the committee approved the Ryan White Planning Council Agenda for the December 9, 2020 meeting.
- B. **Allocations Committee:** John Dornheim, Chair, reported that the committee had an emergency meeting on 11/30/2020 to review and discuss reallocation recommendations. The committee established quorum. The allocation committee discussed the justification data, and request for reallocated funding increases. The allocation committee developed reallocation recommendations for FY 2020 Part A/Part B Dallas/Sherman and State Service Dallas HSDA; each reallocation recommendation was approved by the committee. He provided an overview of the rational and reallocation spreadsheets for the State Services Dallas/Sherman HSDS.
 - The Council received an overview of the Part A Reallocation Spreadsheet. John called for a second to the motion of the Executive committee's motion for the RWPC to approve the Part A Reallocation recommendation as shown on the Part A Reallocation Spreadsheet. Seconded by Robert Lynn. There were six abstentions. The motion passed.
 - The Council received an overview of the Part B Reallocation Spreadsheet. John called for a second to the motion of the Executive committee's motion for the RWPC to approve the Part B Reallocation recommendation as shown on the Part B Re-allocation Spreadsheet. Seconded by Robert Lynn. There were six abstentions. The motion passed.
 - The Council received an overview of the State Services Dallas HSDA Reallocation Spreadsheet. John called for a second to the motion of the Executive committee's motion for the RWPC to approve the State Services Dallas HSDA Reallocation recommendation. Seconded by James Wright. There were six abstentions. The motion passed.
 - The Council received an overview of the Sherman Part B Reallocation Spreadsheet. John called for a second to the motion of the Executive committee's motion for the RWPC to approve the **Sherman** Part B Reallocation recommendation as shown on the **Sherman** Part B Reallocation Spreadsheet. Seconded by James Wright. There were six abstentions. The motion passed.
- C. **Needs Assessment Committee:** The committee did not establish quorum on 11/17/2020.
- D. **Planning & Priorities Committee:** Robert Lynn, Chair, reported the committee met November 18, 2020. The committee conducts a 3-5 minute segment to review Ryan White Bylaws and Roberts Rules to keep it fresh on everyone's mind. The committee discussed How Best to Meet the Need recommendations, thus far to include three service categories: substance abuse, child care services and housing congregate. He announced that he thanked all the committee members for their hard work and mentioned some of the tasks that were accomplished. Finally he announced that the committee will not meet in December 2020; that the committee would reconvene on January 20m 2021. He also announced that he would not be return in January as Chair of the committee as he has taken a position with a service provider which presents a conflict of interest. However, he mentioned that he did apply for a leadership position with another committee. John thanked Robert for a great job done by him and his

committee.

E. Evaluation Committee: Pamela Green, RN, Chair reported that the committee met on November 24, 2020. New business was trying to recruit a member to transition into Del’s role. The committee had a brief discussion about what has been proposed for the evaluation committee and the CQM committee to work together. The CQM was hoping that the committee could be the bridge to the RWPC for some work they want to do. And, the CQM is still persistent with their focus on viral suppression and CD4 count. She proposed to review further in 2021. The committee planned to meet on December 22, 2020 which may pose a conflict for her. She will defer to Del should that happen and advise the administrative staff. John thanked the chair and vice-chairs for their service.

F. Consumer Council Committee: The Office of Support reported the committee met on November 19, 2020 establish quorum and approved minutes. Conducted the introductions and announcement and received their reflectiveness report. The committee liaisons provided reports. The committee will not meet in December. The member will reset over the holidays and resume the forum planning in January FY 2021.

VII. New Business: NA

John thanked the office of support and staff for their efforts.

VIII. Adjournment: John Dornheim called for a *motioned to adjourn. Robert Lynn made the motion. James Wright seconded the motion. The motion passed unanimously. The meeting was adjourned at 9:40 a.m.*

- I. **Call to Order:** John Dornheim, Chair called the meeting to order at 2:01 p.m.
- II. **Certification of Quorum:** Quorum was established by John Dornheim, and certified by Glenda Blackmon Johnson, RWPC Manager.
- III. **Introductions/Announcements:**
- IV. **Approval of December 2, 2020 Minutes:** Lionel Hillard motioned to approve the minutes. Donna Wilson seconded the motion. The motion passed.
- V. **Office of Support:** The RWPC membership, 33 seats 20 filled. 50% of the membership is nonaligned consumers. Three mandatory seat categories: State Medicare/Medicaid; recently incarcerated; and federally recognized Indian Tribes. The RWC is seeking women of Color/Transgender/Youth/Hispanic and Indian Tribe representation. Discussed the standing committee seat status.
 1. Allocation Committee (15 seats): 7 members (8 seats open)
 2. Evaluation Committee (15 seats): 11 members (4 seats open)
 3. Planning & Priorities Committee (15 seats): 9 members (6 seats open)
 4. Consumer Council Committee (20 seats): 15 members (5 seats open)
 5. Needs Assessment Committee (25 seats): 11 members (14 seats open)

MEMBERSHIP REFLECTIVENESS:

- The 1st group impacted with the highest numbers is Blacks at 9,587 or 42% representation; the RWPC membership consists of 20 people of whom 11 are Black with representation at 55.00% reflectiveness.
- The 2nd group impacted with the next highest numbers is White at 6,480 or 30% representation; the RWPC membership consists of 20 people of whom 6 are White with representation at 30.00% reflectiveness.
- The 3rd group impacted with the next highest numbers is Latinx/Hispanic at 5,515 or 23% representation; the RWPC membership consists of 20 people of whom 3 are Latino/Hispanic

with representation at 15.00% reflectiveness.

- Andrea Cokes introduced herself as the newest member of the Ryan White Planning Council support staff. Andrea discussed the goals she has set for FY 2021 then described the steps she will take in order to reach the goals. Andrea announced that the first issue of the RWPC Monthly Newsletter is now in circulation then she encouraged all council members to contribute content for the RWPC monthly newsletter, website, and social medias.
- Glenda Blackmon-Johnson discussed the development for the RWPC 101 Virtual Training and its intent. Glenda informed the committee that the video series will be available on the RWPC website <https://www.dallascounty.org/departments/rwpc/> and all questions can be directed to the office of support.
- Glenda Blackmon-Johnson provided an overview of the RWPC 2021 Work plan. Glenda encouraged committee members to review the documents to familiarize themselves with their committee's specific task for the FY 2021 program year. Glenda extended the opportunity for committee members to reach out, to the support staff, with questions and for additional support.

VI. **Leadership Report:**

- John Dornheim, Executive Committee chair established the platform meeting etiquette and made general announcements regarding access to Emergency Housing Assistance Program; Comprehensive Energy Assistance Program; the HIV Taskforce, Dallas County Fast Trace Cities, COVID-19 Updates and vaccine announcements on the Dallas County website <https://www.dallascounty.org/> ; RWPC new membership interviews; recruitment.
- The committee members conducted a robust discussion about how to conduct the new membership interviews.

VII. **Administrative Agency Report:** Wanda Scott provided administrative updates on behalf of Sonya Hughes. Wanda reported that the Administrative Agencies would be briefing the Commissioner's Court on January 19, 2021 for the HIV Handbook. DCHHS has collaborated with Parkland, via an established Memorandum of Understanding, to develop a comprehensive list of medical services and community resources in the North Texas area to ensure that people with service needs have access to care. She discussed details about the background of the HIV Handbook which included an updated comprehensive list of medical and social services resources; the services provided to the community funded by the local, state and federal resources. Additionally, the handbook will assist providers to make appropriate referrals for individuals at risk and in need of HIV prevention, testing, treatment, medical case management, mental health and substance abuse, and health and social services.

In efforts to streamline monthly billing process and for the reduction of the administrative burden, the AA has communicated guidance through series emails: December 19, 2020 and December 31, 2020; modified the contractual process; and the ARIES backup and service report requirements.

She reported the Part A Formula fund expenditure at 36% of the award; COVID-19 CARESACT funds expended at 3% of the award. Also, that the AA anticipates expenditure percentages to increase with billing submissions and reallocations. City HOPWA contract was executed as of November 2020.

She mentioned that the AA will seek to reallocation funds on 1/25/2020. She mentioned that there is no flexibility regarding the 95% fund expenditure requirement. She petitioned for allocation committee's consideration to render flexibility regarding the 7% levied for the Administrative Agency's discretion by the council. Members presented concerns and questions for clarification regarding reallocation and expenditures.

The Executive Committee interviewed two (2) candidates for standing committee appointment. The committee unanimously assigned Miranda Grant to the Needs Assessment Committee and assigned Kristy Halyburton to the Consumer Council Committee. The committee closed the Executive Session and 3:31 p.m. and reconvened the Executive meeting.

XII. **Adjournment:** Donna Wilson made a motion to adjourn. Lionel Hillard seconded the motion. The motion passed unanimously. The meeting was adjourned at 3:33 p.m.
