

How to Renew your overdue vehicle Registration



March 16, 2020

Governor Abbott issued a waiver of certain vehicle registration, titling and parking placard regulations.



December 15, 2020

Governor Abbott ends the temporary waiver of vehicle title and registration requirements as of **April 14, 2021**.

How to Renew your overdue Vehicle Registration while staying safe and avoiding crowded lobbies, and long wait times.

Step 1

Determine your original Registration Sticker due date.

Step 2

Determine if your vehicle inspection is still valid.

Step 3

Renew your registration prior to April 14, 2021.

Step 1

Determine your original Registration Sticker due date.

- Take a look at the sticker on your vehicle to determine the month of renewal. In this example, it was due in May 2020. Your renewal due date is the last day of the month of renewal. May 31, 2020.



Step 2

Determine if your vehicle inspection is still valid.

- Locate your Vehicle Inspection Report (VIR). If your inspection was performed no more than 90 days prior to your original renewal date, and the inspection is not more than one year old, then it is still valid.
- If you cannot find your VIR, you can go to www.mytxcar.org and enter your VIN number for a history of all inspections on that vehicle. You can also visit the inspection station and get a copy of your VIR.
- In our May 2020 example, the inspection is still valid if it occurred after March 3, 2020.

Step 3

Renew your registration prior to April 14, 2021.

- Determine how you are eligible to renew your registration.
- If your registration is less than 9 months overdue, it's best to renew online at www.dallascounty.org/tax or at a convenient neighborhood location partner (participating grocery store).
- If your registration is more than 9 months overdue, the Texas Department of Motor Vehicles requires you to register by mail or in person at your local Tax Office.

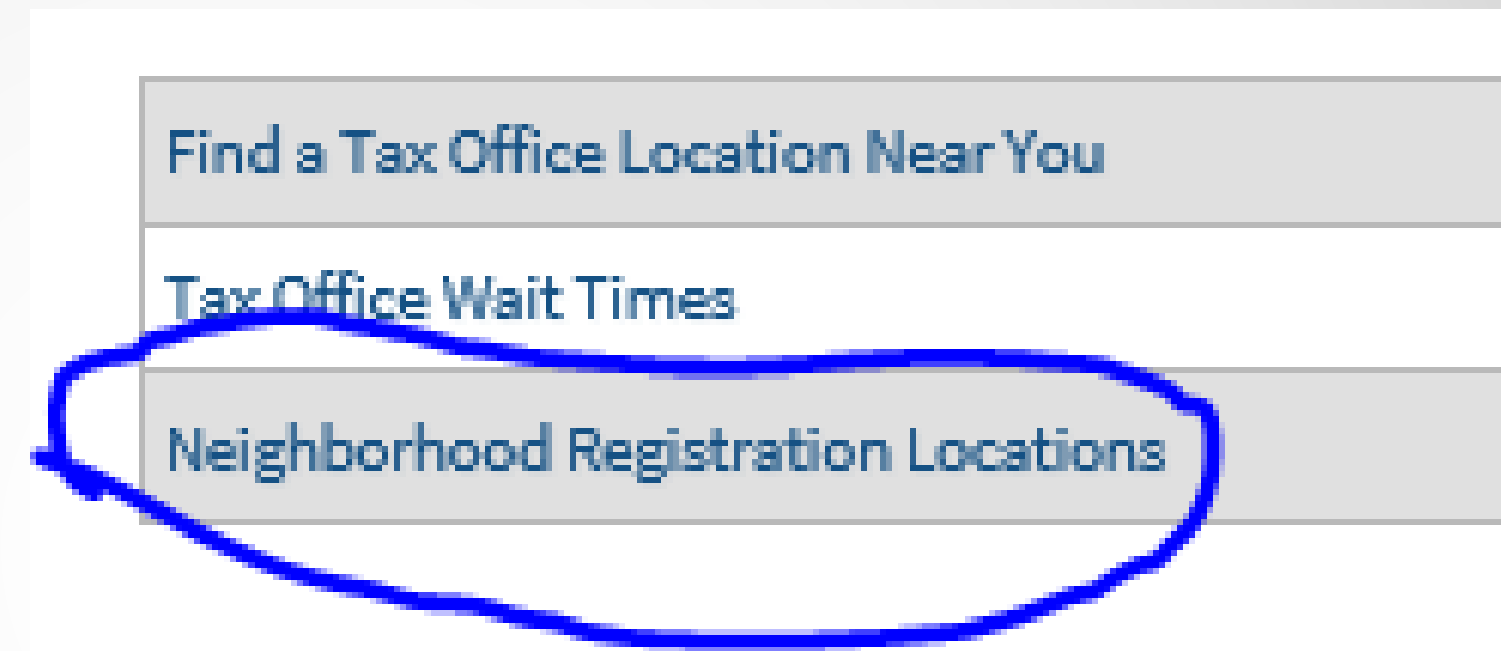
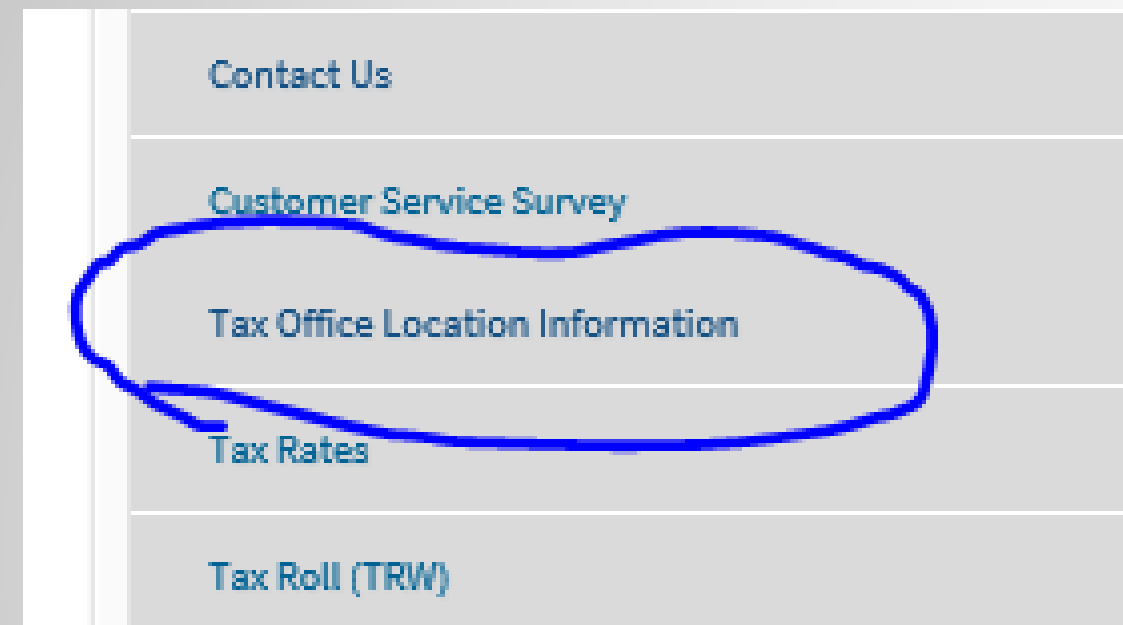
