These investments could mean raises for employees. Quarterly, the Treasurer's Office provides a deposit error report card to departments who have made errors. If you have not received one, you are doing great! This is to encourage everyone to stay consistent and correct any error. We encourage all departments who deposit to the Treasurer's Office to reach out to us if they would like a presentation on deposit training. This includes tips that can help your team be more efficient and copies of the presentation.
