# Did you miss the TCDRS Webinar?



Check out some great questions employees asked TCDRS!

#### What happens to my money if I leave Dallas County?

When you leave Dallas County, you have the option to withdraw your money, roll it over to another financial institution, or leave it to accumulate 7% interest. From there your TCDRS account will continue to build compound interest until you decide to withdraw it, roll it over, or come back to Dallas County.

#### Can I rollover money from my other 401k into my TCDRS account?

\*No. The only way you can put money into your TCDRS account is by contributing 7% of your Dallas County paycheck to your TCDRS account, which is a mandatory contribution for full time Dallas County employees.

\*\*You can roll over your 401K to your Dallas County Nationwide 457b account.

#### I just started with Dallas County. Why does retirement matter?

Think of retirement with Dallas County as an investment and savings account. Learning about what you contribute in could help you with making future decisions. For example, do you leave your Dallas County job for another which may only offer a 401k?

Dallas County's Retirement pension guarantees a lifelong monthly income for retirees, while 401k plans depend on contributions and investment choices. Dallas County employees are also offered an additional investment and retirement saving account through Nationwide's 457b account. You never hear, "I have saved too much money for retirement!" Think of the Nationwide 457(b) as a side gig, extra money you get when you retire, because you planned and put as little as \$10 in this account while you were a Dallas County employee.
