

**1. Overview**

1.1. This document establishes the “Fred Van Liew for Justice of the Peace” campaign organization.

1.2. The mission of this organization is:

1.2.1. To achieve the election of Frederic R Van Liew (Fred) as Justice of the Peace District 4 -1

**2. Launch**

2.1. This campaign organization is considered operational as of January 10, 2026.

2.2. The initial address for launching the organization is a residential address:

4.1. **5. Financial Management**

- 5.1. This organization will accept donations from supporters in accordance with all local, state, and federal laws, orders, and regulations pertaining to the acceptance of donations as a political organization acting as the campaign for a candidate running for a political office in the state of Texas and under the laws of the United States of America.
- 5.2. It is the duty and responsibility of the Treasurer of the organization to ensure compliance with the requirements of this section.
- 5.3. All documents required by law for reporting financials of the organization shall be filed in accordance with the deadlines and requirements of the application laws.


**6. Conditions for Closing the Organization**

- 6.1. This campaign's operations are tentatively set to end February 1, 2027.
  - 6.1.1. Depending on the results of the 2026 elections, this campaign's operations may continue beyond this date.
- 6.2. Should Fred withdraw from pursuing any political office, this organization will be dissolved within 30 days after appropriate wrapping up operations are completed.

**6.3. Wrapping up operations shall include:**

- 6.3.1. Payment of all debts owed at time of winding down operations.
- 6.3.2. Auditing and completion of all Local, State, and Federal financial and other legal documents for closing the campaign in compliance with all laws, orders, and regulations.
- 6.3.3. Closing of all accounts established for the campaign organization, including all accounts on or with:
  - 6.3.3.1. social media,
  - 6.3.3.2. banking, and
  - 6.3.3.3. vendors/services.
